

# Revealing: Prize Draw Terms and Conditions

## 1st August 2011 to 4th September 2011

1. The entry instructions form part of these rules. Entry to the prize draw is made by logging in to [justadviser.com](http://justadviser.com) and correctly answering the three questions between the 1st August 2011 and 4th September 2011.
